HERE'S HOW IT WORKS:

The Garcia family makes \$50,000/year and pays \$2,475 in Illinois state income taxes.

Family Income \$50,000/year	Option A	Option B	Option C
Illinois state taxes at 4.95%	\$2,475	\$2,475	\$2,475
Invest in Kids donation	\$500	\$1,000	\$3,300
Tax refund	\$375	\$750	\$2,475
Total taxes paid to Illinois (after refund)	\$2,100	\$1,725	\$0
Cost of donation to family after refund	\$125	\$250	\$825
2-for-1 matching gift program triples impact and provides three times the scholarships	\$1,500	\$3,000	\$9,900

Each option provides a refund back to the family, however **Option C** completely eliminates the family's tax burden and provides nearly \$10,000 in scholarships for students to attend Catholic schools.
